

# Fatsco Privacy Policy

---

This privacy policy has been compiled to better serve those who are concerned with how their personally identifiable information is being used online. Your privacy is important to us, so please read our privacy policy carefully to get a clear understanding of how we collect, use, and protect your personal information.

## **What personal information do we collect from people that visit our website?**

When ordering or registering on our website, as appropriate, you may be asked to provide your name, address, phone number, email address, credit card information. This information collected, that you provided, is specific personal information gathered during the purchase of goods and /or services from our site. We only use this information provided about yourself to fulfill your order for our goods, to respond to your inquiries, or provide you with the status of your order.

## **How do we protect your information?**

Our web store is scanned on a regular basis for security risks and vulnerabilities in order to make your visit to our store as safe as possible. Our store is hosted with Ecwid, an e-commerce platform. Ecwid is PCI DSS\* certified Level 1 Service Provider which is the highest international standard for secure data exchanges for online stores and payment systems.

\*(Payment Card Industry Data Security Standard).

All of the data in our store – products, customers, and general information is stored with Ecwid on a secure hosting server – Amazon Web Services, the most reliable and secure solution.

Our store is always launched using an HTTPS connection. You can always verify this by inspecting the Network session. In order to indicate that any form data is secure, look for the padlock image on the checkout page. Form data will be sent over an SSL-encrypted connection.

All payment transactions are processed through a gateway provider and are not stored or processed on our servers.

## **Do we use cookies?**

Yes, a cookie is a small file, which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyze web traffic. Cookies allow web applications to respond to you as an individual, which in turn helps us to provide you with a more personalized user experience. For example, we use cookies to help us remember and process items that you place in the shopping cart.

You can chose to accept or decline cookies, or have your computer warn you each time a cookie is being sent. This option can be done through your browser settings.

## **Do you sell my information to Third Parties?**

No, we do not sell, trade, or otherwise transfer any of your personal information. We also do not include or offer any third party products on our website.

## **Do you work with Google Analytics cookies?**

Yes, Google as a third party vendor, uses first party cookies to compile data regarding user interactions with ad impressions and other ad service functions as they relate to our website.

## **Addresses**

When you purchase from our web store, we collect your Internet Protocol (IP) address to track and aggregated non-personal information. For example, we use your IP address to monitor regions from which users navigate to our website.

We also collect your IP address when you log into your account as part of our security features.

## **Changes to this policy**
